

2011 AGRA Royalty Guidelines

- I. Royalty categories will be:
 - A. Mr AGRA
 - B. Ms AGRA
 - C. Miss AGRA
 - D. MsTer AGRA

- II. Eligibility for Competition
 - A. Be an AGRA Member in good standing
 - B. Complete the Application for AGRA Royalty Competition
 - C. Pay a twenty-five dollar (\$25.00) entry fee
 - D. Submit the application and entry fee to the AGRA Vice President before announcing candidacy
 - E. Submit 501c non-profit certificate of eligibility for selected organization
 - F. Application, entry fee, and 501c non-profit certificate of eligibility must be submitted by September 1, 2011
 - G. On application list at least one 501c non-profit organization in Arizona
 - H. Reside in the State of Arizona when application and entry fee are submitted

- III. Requirements for Competition
 - A. Raise a minimum of one hundred dollars (\$100.00) for at least one 501c non-profit organization in the State of Arizona
 - B. Raise a minimum of three hundred dollars (\$300.00) for AGRA operating expenses
 - C. All money must be raised and turned into the AGRA Vice President by midnight on the last day (September 15, 2011) before the royalty competition

- IV. Competition
 - A. Competition will be held Friday, September 16, 2011
 - B. Competition will consist of three (3) segments
 - C. Interview comprised for five (5) questions
 - D. Public Appearance
 - E. Entertainment
 - F. Judging will be by a panel of a minimum of five (5), and up to a maximum of seven (7) judges
 - G. Attire for all competition segments
 1. Mr candidates must wear male attire
 2. Ms candidates must wear female attire
 3. Miss candidates must wear female attire
 4. MsTer candidates must wear male attire
 - H. Each judge may award points from 1 to 50 for each segment
 - I. The highest and lowest scores in each segment will be removed

- J. For each category (Mr, Ms, Miss, MsTer), the individual who raised the most money for AGRA will be awarded an additional 50 points. Each contestant will be awarded points for money raised for AGRA with points separated by 5. (Example: 2nd highest amount of money=45 points, 3rd highest amount of money=40 points, 4th highest amount of money=35 points, etc, until all contestants have been awarded points.)
- K. In the event two contestants receive the same total score, the tie will be broken by:
 - 1. Adding in highest and lowest scores in each segment
 - 2. If a tie still exists, the highest interview score will be used to break the tie
- V. Selection and Announcement of Winners
 - A. An audit committee, comprised of three (3) individuals, will collect the judges' sheets and total points
 - B. Announcement of winners shall be made by the AGRA Vice President, or his designee, following the competition
 - C. Depending on the number of candidates for each category, winners may be:
 - 1. Mr AGRA, Mr AGRA 1st Runner-Up, and Mr AGRA 2nd Runner-Up
 - 2. Ms AGRA, Ms AGRA 1st Runner-Up, and Ms AGRA 2nd Runner-Up
 - 3. Miss AGRA, Miss AGRA 1st Runner-Up, and Miss AGRA 2nd Runner-Up
 - 4. MsTer AGRA, MsTer AGRA 1st Runner-Up, and MsTer AGRA 2nd Runner-Up
- VI. Awards
 - A. Mr, Ms, Miss, and MsTer AGRA will receive a buckle
 - B. Miss AGRA will also receive a crown
 - C. Mr, Ms, Miss, and MsTer AGRA 1st and 2nd Runners-Up will receive a ribbon
 - D. Mr, Ms, Miss, and MsTer AGRA will also receive a \$200.00 check from AGRA.
- VII. Length of Reign

Reign for each title holder will be from time of announcement through February 29, 2012
- VIII. Retention of Title

All title holders must remain an Arizona resident throughout reign to retain the respective title
